HOW TO APPLY

The request for the partial exemption must be made by email to formazione@polidesign.net underlining our own motivations and qualities at the base of the partial exemption application.

The request and the award of the partial exemption take place during the Master's admission process, never after its the starting date.

Partial exemptions are only available for those who will submit the application for selection and participation in the 1st level Specializing Master COLOR DESIGN AND TECHNOLOGY, year 2018/2019 Decreto Rep. n° 1948 Prot. n° 33515 Data 20.04.2017.

ASSIGNMENT CRITERIA AND REQUIREMENTS

Partial exemptions will be awarded until their exhaustion, in chronological order of enrollment. Registration is formalized with the payment of the deposit provided for by the Private agreement to POLI.design and the subscription of the Private agreement.

The initiative is valid from 01/11/2017. Partial exemptions are only available for those who will formalize their registration with the payment of the deposit from 01/11/2017. The list will consider the date of the money transfer.

To request partial exemptions, candidates must attach to the admission request the following documentation:

- Admission form (available here www.polidesign.net/en/colordesign/admission)
- Curriculum vitae;
- Portfolio;
- Self-certification relating to personal identity (name and surname, date and place of birth, nationality and residence);
- Copy of the passport in effect
- Photocopy of the academic transcript in the original language detailing the marks obtained for each examination, plus the translation in Italian, English, French or Spanish, or the Diploma Supplement (upon enrolment, the Declaration of Value from the local Italian Diplomatic authorities must be submitted, or an Official document issued by ENIC/NARIC centers).

Partial exemptions are not cumulative with other scholarships, exemptions or financial aid for the Master attendance. Acceptance of partial exemptions is exclusive.
