N.3 (three) partial exemptions of 25% available on the total amount for the **Specializing Master STRATEGIC DESIGN. BUILDING NEW BUSINESSES AND STRATEGIES THROUGH DESIGN year 2018/2020.**

How to apply

The request for the partial exemption must be made by email to formazione@polidesign.net

The application and the assignment of partial exemptions take place during the admission to the Specializing Master, and never after its starting date.

Admission to the Master is independent of the possible assignment of the partial exemption.

Requirements

Partial exemptions are awarded on the basis of the criteria mentioned below and on the basis of the requirements present in ART. 5 of Decree N. ° 7493 Prot. n° 110886 Data 27.11.2017

In evaluating candidates and assigning partial exemptions, the Master Board will consider:

- English language (10 points maximum).
- Motivation (10 points maximum).
- Written text (open questions) (10 points maximum).
- Interaction during the interview (in person or via Skype) (10 points maximum)

Total maximum score 40 points

The minimum evaluation score to compete for partial exemptions is 35/40.

List of documents to be attached to the application for the selection process:

- Application Form (Downloadable on www.polidesign.net/en/mds/download)
- Updated Curriculum Vitae;
- Portfolio
- Copy of the academic certificate plus to certificate detailing the marks obtained for each examination, or the Diploma Supplement (upon enrolment, the Declaration of Value from the local Italian Diplomatic authorities must be submitted, or an Official document issued by ENIC/NARIC centers);
- A copy of the student's Identity Document.

Partial exemptions are not cumulative with other scholarships, exemptions or financial aid for the Master attendance.

Partial exemptions are only available for those who will submit the application for selection and participation in the 1st level Specializing Master STRATEGIC DESIGN. BUILDING NEW BUSINESSES AND STRATEGIES THROUGH DESIGN year 2018/2020 established and activated with Decreto Rep. n° 7493 Prot. n° 110886 Data 27.11.2017.

The selections will take place in chronological order according to the date of receipt of the application, as long as the available seats are exhausted

Deadline and communication

The deadline for requesting partial exemption is 29/06/2018 at 1pm (Italian time).

Only those who will be eligible will receive written notice from POLI.design within 06/07/2018

Within 2 days from receipt of the notice, candidates who have received communication must send a statement of acceptance of partial exemption written in free form to formazione@polidesign.net.

By 27/07/2018, candidates who have accepted the partial exemption must proceed to the formalization of the enrollment and proceed to the payment of the first installment of € 4.000,00 or they will lose the right on the same, and the awarding of the exemption will be processed to the candidate or candidates immediately following in the ranking.

The registration is formalized with the payment of the first installment of € 4.000,00 to POLI.design and with the subscription of the private agreement.

The initiative is valid until 29/06/2018 h. 1pm (CET).

POLI.design reserves the right not to allocate all available partial exemptions, if there were no candidates with the appropriate requirements.

All partial exemptions can be modified without notice.
