1. DEFINITIONS

Data Processing	Any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.



The provision of personal data requested when filling out the forms on the site https://www.polidesign.net or on the site of suppliers specialized in the guide to the choice of services, appointed by us, is mandatory for purposes contained in the paragraph PROCESSING PURPOSE and LEGAL BASIS points A and B of this Notice.

Conversely, failure to provide consent for the purpose contained in the paragraph PROCESSING PURPOSE and LEGAL BASIS point C of this information will not make it possible to receive messages, by subscribing to the relative mailing list, concerning information messages and / or commercial and / or promotional communications.

7. PLACE OF DATA PROCESSING and PROCESSING METHOD

Your data is processed within the European Union. All processing operations are carried out by means of computer / electronic tools, including automated ones, and on paper.

9. COMMUNICATION OF YOUR DATA TO THIRD PARTIES

The Data Controller has entrusted the development and maintenance of the site to a specialized supplier. 10. STORAGE PERIOD OF COLLECTED DATA


Your data collected for the purposes described in the paragraph PROCESSING PURPOSE and LEGAL BASIS:

- will be kept for the purpose indicated in point A of the aforementioned paragraph and will be deleted within two years from the last response sent to your message by the Data Controller, unless you have consented to receive commercial proposals on products, activities and services institutional of POLI.design;
- they will be kept for the purpose indicated in point B of the aforementioned paragraph for the entire duration of the judicial dispute, until the terms of enforceability of the appeals are exhausted;
- will be kept for the purpose indicated in point C of the aforementioned paragraph until the request for cancellation by you or revocation of consent.

11. YOUR RIGHTS

The interested parties have the right to obtain, in the cases provided for, access to their personal data and the correction and / or cancellation of the same and / or the limitation of the processing that concerns them and / or to oppose the processing (articles 15 and ss. of the GDPR). The specific request must be submitted directly to POLI.design at the addresses indicated in the DATA CONTROLLER paragraph of this Notice.
